NTNI missionaries are involved in Teaching & Discipleship (including Pastoral duties, teaching in schools, and mentoring leaders), Evangelism (includes all outreach programs, i.e. medical clinics, orphanage visits and hosting missions teams) and Administrations of Church, School and Evangelistic efforts (including curriculum development and managing churches and schools).

**Teaching & Discipleship** - This area of ministry is primarily church and school activities, although the Evangelism area is also a teaching and maturing area. The goal is to teach and train national individuals to be prepared to "do the work on the ministry" in their countries. Thus all areas encompass this. 14 missionaries serve on 15 church staffs as either Pastors, Associate Pastors or in help positions. Those missionaries mentored 94 (an average per quarter) national pastors & other church leaders. 13 taught in 12 Bible schools, each term had an average of 53 Bible classes and 41 other classes taught. 121 leadership training sessions were conducted. 70 home or cell churches met each week. Over the course of the year; 72 women's meetings were held, 3 men's meetings, 173 youth ministry meetings and 102 children's ministry meetings were held.

**Evangelism** - This area of ministry serves a twofold purpose; to introduce individuals to Christ and to train nationals to be able to accomplish these activities on their own. 220 orphanage visits were made and 24 evangelic films were shown. 44 missions teams from the U.S. were hosted by NTNI missionaries with 648 team members from the U.S. 54 crusades and 118 street ministry sessions were conducted. 22 medical clinics treated 4,640 patients, these clinics were coordinated by NTNI missionaries and conducted by teams from the U.S.
