NTNI missionaries are involved in Teaching & Discipleship (including Pastoral duties, teaching in schools, and mentoring leaders), Evangelism (includes all outreach programs, i.e. medical clinics, orphanage visits and hosting mission teams), and Administrations of Church, school and Evangelistic efforts (including curriculum development and managing churches ad schools).

TEACHING & DISCIPLESHP: This area of ministry is primarily church and school activities, although the Evangelism area is also a teaching and maturing area. The goal is to teach and train national individuals to be prepared to "do the work of the ministry" in their countries. Thus all areas encompass this goal. 17 missionaries serve on 14 church staffs as either Pastors, Associate Pastors or in helps positions. Those missionaries mentored 64 (an average per quarter) national pastors & other church leaders. 13 taught in 16 Bible schools with an average of 77 Bible classes and 48 other classes per quarter. 210 leadership training sessions were conducted. 77 home or cell churches met each week. Over the course of the year, 109 womens meetings were held, 6 men's meetings, 193 youth ministry meetings, and 83 childrens ministry meetings were held.

EVANGELISM: This area of ministry serves a two-fold purpose; to introduce individuals to Christ and to train nationals to be able to accomplish these activities on their own. 57 orphanages were visited on a regular basis, 6 evangelistic films were shown, 91 teams from the U.S. were hosted by NTNI missionaries with a total of 1,322 team members, 27 crusades and 98 street ministry sessions were conducted. 20 medical clinics treated over 5,000 patients, these clinics were coordinated by NTNI missionaries and conducted by teams from the U.S.
